

Minutes of Meeting — July 15, 2024

Report from Director Chair, Mike Cyr

- We have a Director who has not been active this year and not responding to correspondence. Director voted to withdraw his authority. Now seeking a replacement for this position, to keep a total of five Directors.
- Directors suggested that maybe a collection bin for returnable bottles be placed at the County Road Store in Milford as a revenue source for the Club. Vinal will contact Mike the owner of the store to ask permission and, if approved, secure a place for a bin.

<u>Treasurer's Report — Melissa Dow Doane</u>

- Reporting period (since June 17): income \$117.00; expenses \$2,098.06
- Year since 01/01/24: income \$28,352.73; expenses \$21,358.43; bank balance \$7,964.79
- Purchased a Trail Master trailer. Budgeted \$3,000, and found a trailer for \$1,700.
- Insurance for the building costs \$1,400 per year

<u>Trail Master's Report — Dave Soucier</u>

- Overall, our trails are in great shape: no closures and areas needing extra caution have been well marked.
- Many new signs have been added in the past month, plus other signage augmented as we have been riding the trails, noting signage where missing. Newly purchased "Access Route" signs need to be added to Greenfield Road.
- Road grading now going on Trail 512 north. The beaver dam is still there, but easier to navigate.
- Road grading will soon start on Trail 512 south, Trail 704 etc. and other AFM roads.
- Trail maintenance work will commence soon on Trail 703B, a connector trail.
- Gravel that was gravel dropped last fall will be placed in Trails 702, 702A and 701.
- Brush hogging will start soon on Trail 703A, with gravel work soon on Trails 702 and 702A.
- We will be working on the trail at Alexander's improving, smoothing out.
- We will be ditching some trail to help with rain runoff drainage.
- Tree growth is crazy this year. In the late summer/fall, we will be asking for volunteers to help cut back the tree growth that is narrowing the passage on some of the trails. Stay tuned.

- Vinal has been digging up septic tank cover in preparation for pumping of the septic tank on Friday (7/19). We don't believe the septic tank has ever been pumped.

Old Business

- For those who didn't see a post on the access to Route 178 to connect Milford and Bradley, it is currently a "NO GO". There are still some ideas to research; some on private land, some Town of Milford.
- Haven't received an update recently regarding the Kingsbury Road possible connection (by the landfill).
- Outside motion light still needs to be installed soon!

- Another group ride is planned for Saturday July 27. Discussed possible ride routes. Trailer to Lagrange and ride to Milo or Millinocket? Ride to Machias? Ride to Grand Lake Stream? Lively discussion with nothing decided (yet).
